- \* Apparel Sales, about broke even -- \$180 "in the hole" with a few items left

- \* 50/50 Sales = \$1088

- \* Wheel barrel of booze Sales \$1565

- \* Took in \$11,718.98

### New Business

- Christmas Event for Students (Consider to fund)
 

Some of the teachers have discussed making breakfast for the students the last day of school before Christmas Break. They also are thinking about inviting the Jolly Old Elf himself, Santa. Last year the PTC provided \$350 for the Christmas Family Fun Night. Discussion was tabled until November's meeting.

**Motion was made to purchase Hershey's Chocolate Candy Bars for Santa to hand out instead of peppermint candy canes, not to exceed \$130: Kaylan Second: Danielle**
- Snowman Craft (Consider to fund)
 

Consider funding snowman craft for all students to participate in making the Monday before Christmas Break. The teachers would need 7 boxes and each box is ~\$13.58 each. Mrs. Winter estimated the cost would be about \$110 with shipping and tax (maybe a bit more). This craft would be instead of making gingerbread houses.

Would the PTC like to gift each student with a winter hat? The hats would be red and white with "St. Libory Saints" on them. Becky called Positive Promotions. Price for 70 hats is \$517.30 with S&H and tax is \$576.79. Three weeks to get hats and need to be ordered after PTC meeting tonight. (~\$7.50 per hat)
